Installation of the OSDS system must be completed either within three months of the recording of the Agreement and Easement or by June 30th of the State of Maryland fiscal year in which this application is submitted, whichever comes first. If the OSDS is not installed within this timeframe resubmission of this application may be required. Requests for an extension must be submitted to the SCHD in writing.

AGREEMENT AND EASEMENT FOR INSTALLATION OF BEST AVAILABLE TECHNOLOGY SYSTEMS WITH BAY RESTORATION FUNDS

WHEREAS, the Bay Restoration Fund (BRF) may provide a grant for the cost attributable to upgrading an onsite sewage disposal system (OSDS) to the Best Available Technology (BAT) for the removal of nitrogen.

WHEREAS, the BRF may also provide a grant for the cost difference between a traditional OSDS and a system that utilizes the BAT for the removal of nitrogen.

NOW, THEREFORE, the parties hereto agree as follows:

- A. Owner hereby grants to the County and the Department the right to enter upon the property at any reasonable time for access to the system to make periodic inspections and the Owner agrees to provide any information and data requested and needed by the Department and/or County to develop accurate and thorough test results.
- B. Owner acknowledges and agrees that a manufacturer-approved installer will install the BAT system.
- C. Owner acknowledges and agrees that the manufacturer will provide for Operation and Maintenance of the BAT for a period of 2 years as a condition of sale of the BAT.
- D. Owner acknowledges and agrees that the manufacturer appointed Operation and Maintenance provided will have access to the BAT at all times.

- E. Owner acknowledges and agrees that following the initial 2-year period, a service contract for Operations and Maintenance of the BAT will be maintained during the lifetime of the system at the behest of the property owner.
- F. Owner acknowledges and agrees that the manufacturer or manufacturer's designee will have access to sample the effluent of the BAT system.
- G. Owner acknowledges and agrees that the proposed installation of a BAT system funded by the BRF is voluntary.
- H. Owner acknowledges and agrees that there shall be no liability on the party of the County or Department to Owner if this BAT system fails, and that the County and the Department do not warrant or guarantee that the BAT system will adequately or properly function.
- I. Owner acknowledges and agrees that neither the County nor the Department nor any of its agents or employees either officially or individually underwrites the operation of any system approved by them.
- J. Owner acknowledges and agrees to devote such care and effort to the maintenance of the BAT system so that any malfunction is not the result of poor maintenance, faulty operation or neglect.
- K. The County and/or Department agree to grant \$ ______ toward the cost of installation of the BAT system, and financial responsibility is limited to this amount. Operating costs will be at the Owner's expense.
- L. Owner acknowledges and agrees that the BRF grant can only be used for that portion of the OSDS attributable to (BAT) for the removal of nitrogen.
- M. Owner acknowledges and agrees to contact the County at least 48 hours prior to the installation, so that the County has the opportunity to be present at the time of installation or thereafter for inspection.
- N. Owner acknowledges and agrees that they must install the BAT system according to the manufacturer recommended plans and specifications approved by the Department.
- O. Owner acknowledges and agrees that if installation deviates substantially from the approved plans or changes such that performance of the system is compromised or reduced, BRF funding will not be provided.
- P. This agreement shall run with the land and binds the Owner, their heirs, successors, assigns in title.
- Q. Owner agrees that they shall inform in writing any purchaser or lessee of the property that the system requires lifetime maintenance. Owner further agrees that they shall inform in writing any purchaser or lessee of the property that the system may require additional maintenance or other attention.
- R. Owner agrees to record this agreement in the land records of Somerset County.

- S. This agreement shall not be construed to limit any authority of the County and/or Department to protect the public health, safety or comfort or to issue any other orders to take any other action that is now or may hereafter be within its authority.
- T. This agreement may be voided at the discretion of the County and/or Department if the OSDS construction is not completed within three (3) months of the effective date of this agreement.
- U. This agreement contains the entire agreement and understanding between the County and the Owner and the Department. There are no additional terms other than as contained in this agreement. This agreement may not be modified except in writing signed by each of the parties or by their authorized representatives.
- V. The laws of the State of Maryland govern the provisions of all transactions pursuant to this agreement.
